Behaviour Management Agreement

Requirements

1. Expected standards of behaviour for students

Expected standards of behaviour are set out in the Standard terms and conditions of the student's Enrolment agreement.

At school:

- participate actively at school
- take responsibility for their own behaviour and learning
- respect other members of the school community and the school environment and property
- cooperate with staff and others in authority
- comply with school rules.

In homestay:

- respect members of the family, their property and the home environment
- participate actively as a member of the household
- take responsibility for their own behaviour
- comply with household rules
- comply with the homestay provider's decisions about their actions and welfare, including outings and curfews
- keep the homestay provider informed of their whereabouts, and remain contactable by them, at all times.

Travel and activities: (while living with homestay provider):

- obtain permission for non-routine activities
- not undertake high-risk activities
- not be a passenger in a vehicle driven by an unlicensed driver or learner driver
- obtain permission to be a passenger with a provisional (p plate) driver
- only drive a vehicle if they have a driver's licence and parental approval

At all times:

- comply with Australian laws and student visa conditions
- not drink alcohol, smoke, misuse prescription medication or use illegal drugs
- not do anything that endangers their own safety or the safety of other people
- not do anything that may bring the school or the international student program into disrepute.

INTERNATIONAL CURFEW AGREEMENT

_____ (Name of student) agree to support and implement the school curfew times. We agree to the following:

The curfew hours that International Students must adhere to as per the EQI Student Code of Conduct and Programme Rules are as follows:

- **Sunday, Monday, Tuesday, Wednesday and Thursday nights:**
Junior High (Years 7-10) students must be home **by 6:00pm**
Senior High (Years 11 & 12) students must be home **by 7:00pm**
*unless they are involved in a sport arrangement or extracurricular activity, which must be submitted for approval by Mrs Gutwein.
- **Friday and Saturday nights:**
Junior High (Years 7-10) students must be home **by 9:30pm**
Senior High (Years 11 & 12) students must be home **by 10:30pm**
- **Homestay family:** If Curfew is not met by student/s, I will advise the international staff by email the following day. I understand that if I do not enforce the school curfew rules, I am not complying with the Homestay Code of Conduct and it may result in the student being removed from my care and not being able to host within the EQI Programme any longer.
- **Student:** I will abide by my curfew. I understand that if I do not abide by the Curfew Agreement then appropriate disciplinary actions will be taken.
